1.	The total number of section of the school shall be restricted to 9 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.

2.	Compliance of the points no. 1 to 10 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
<b>Sl. No.</b>	<b>CONDITIONS FOR COMPLIANCE</b>
1	The total number of section of the school shall be restricted to 9. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.
2	The school has uploaded the revised land certificate dated 31/03/2023 in mandatory public disclosure covering land area (15838.50 sq mt) for school building and playground. The school is directed to upload the same certificate in SARAS portal as compliance. Further the school is directed to apply for correction of land area in the OASIS when the portal will be opened for increase / decrease of land area.
3	The school has converted regular cubicles into CWSN toilets but they are too small for a wheel chair/walker to navigate. The school shall construct separate toilets for CWSN, boys and girls on every floor with permanent signage and indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS.
4	The school seems to have overlaid a ramp over an existing stair case as result of which the ramp is very steep and not as per norms. The school shall reconstruct/alter the same as per norms of RPwD Act and guidelines issued by the Board and submit compliance on SARAS within months.
5	The school library needs to be stocked well with a separate reading area for staff. The school shall upgrade its library as per SoP issued by the Board and submit compliance within 3 months on SARAS.
6	Failure to submit compliance for the above mentioned points within prescribed time shall invite financial penalty against the school.
7	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
8	The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.
9	The school shall get all the mandatory certificates renewed periodically.
10	The school shall follow the SoPs of the Board for its labs, library and sports facilities.

The above is subject to fulfillment of the following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly

5. The school to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
